	Outcome/Action
1.Opening Remarks	
The Acting Chair, Andrew Ramsay welcomed those present and thanked everyone for attending what was the first meeting of the session but also the last gathering of the existing Community Council, pending the outcome of the ongoing elections.	
2. Minutes of Meeting held on Wednesday, 5th June 2019	
It was pointed out that while Cllr Sharkey had been present at that meeting, his name had been omitted from the sederunt	
The heading at Section 5 should also be amended to read "Business arising from Minutes of Meeting held on Wednesday 8th May 2019" as that had not been updated while the minutes were being drafted.	Approved
Subject to inclusion of those amendments, the minutes of the previous meeting were proposed as an accurate record by Graham Paterson and this was seconded by Jean Ramsay.	
3. Business arising from Minutes of Meeting held on Wednesday 5 th June	
Proposed Development of Surplus Land at Dykebar Hospital Thornly Park Village	
The Secretary explained that as Cala, Bellway and Barratt Homes had organised a public consultation event at Hunterhill Community Centre, he had not extended a fresh invitation to CBRE to this meeting.	

The purpose of the event was to get input from the community prior to the submission of a detailed planning application for a residential development on the surplus land at Dykebar Hospital, to be known as Thornly Park Village.

The Chair reported that he had attended the consultation event that had been held on the previous evening and had tried to get some idea of their position regarding the Community Council's concerns over adequacy of infrastructure and local services given the various ongoing housing developments in and around the area.

While the developers appear to acknowledge that these issues exist, no substantive proposals were offered to mitigate those other than that they were prepared to make an undisclosed contribution towards improving school capacity. However, St. Andrews Academy is already over capacity before taking into account the prospective intake from the new developments.

Secretary to follow up by writing to Fraser Carlin and the respective Community Councils.

After a lively discussion of the issues, it was agreed to pursue this aspect further by writing to Fraser Carlin, Head of Planning & Housing at Renfrewshire Council so that the Community Council's concerns over these important issues are on record. It was agreed also to write again to Lochfield and Hawkhead Community Council so that they are aware that as a Community Council, we remain concerned about the impact of the development

Given the ongoing development at Blackbyres in Barrhead, which could also impact on the road network through the south east area of Paisley, it was agreed also to raise these concerns with the Community Council serving Barrhead.

HGV Strategy in Renfrewshire & Related Governance Concerns

Following previous discussions on this issue, it was agreed to extend a fresh invitation to Cllr Iain Nicolson to come along to a meeting to discuss the Community Council's concerns.

In the first instance, it was agreed that, subject to the Community Council being reconvened following the elections, to invite Cllr Nicolson to the meeting due to take place on 13th November. However, recognising that the Council Leader might not necessarily be available on that evening, it was agreed to send dates of the meetings organised for the rest of the session so that, if necessary, he can advise regarding his availability at a future date.

Secretary to contact Councillor Nicolson's Secretary

The Secretary confirmed that he would contact Cllr Nicolson's office with a view to organising his attendance at a future meeting

While on this issue, it was mentioned that while the local Regional Transport Strategy for 2017-2027 is due for review, this apparently includes no references to HGV movements.

HGV Movements in Arkleston Road

With the recent closure of Arkleston Road to allow resurfacing works, the Chair explained that he had tried to find out if the Council has made any enquiries to ascertain to where HGV traffic has been displaced during this period.

Concern has been expressed regarding the lack of information concerning the likely timescale to complete the resurfacing work and the local retailers are not happy with the disruption this has caused.

Continued for further discussion

It is noted that despite concerns previously expressed regarding the speed bumps on Arkleston Road, those are to remain *in situ*.

It was suggested that it might now be appropriate to press for a fresh consultation regarding alternative traffic calming measures on the road and it was agreed to look again at suggestions for possible alternative proposals on which Renfrewshire Council could be asked to consult residents.

Unauthorised Structure at 74 Arkleston Road, Paisley

Members were referred to a copy of letter dated 8th July from James Weir, Planning Officer at Renfrewshire Council with an update on application. The applicants have submitted a revised application to retain only the rear section of the development.

In view of this material change the application has been re-advertised so that interested parties can comment further.

Following consultation with members, a further representation by way of a formal objection had been lodged in the following terms:

Whilst noting the recent changes at the site, with part of the structure having been demolished, we remain of the view that the site is already over-developed and granting the retrospective application, even as amended, will only serve to exacerbate the situation.

It was reported by John Bell that a substantial part of the structure has indeed since been demolished and removed, apart from the section to the rear.

However, the retrospective planning application has recently been granted, subject to certain conditions. This includes the stipulation that the remaining structure is not to be used for business/commercial purposes,

Road Safety Concerns/Cycling Infrastructure at Arkleston Road-Hawkhead Road Corridor

Following previous discussions regarding these issues, the Secretary referred members to the copy of a report titled "Glasgow Road / Hawkhead Road / Arkleston Road Junction Tackling Dangerous Junctions

Feasibility Study" prepared by Local Transport Projects in June 2018 at the behest of Renfrewshire Council. A copy of this report had been sent to the Secretary by Cllr Sharkey and circulated to members prior to the meeting

A brief discussion took place following which it was agreed to note the terms of the report for the time being

Community Council Elections

The Secretary reported briefly on the publicity campaign over the summer months in preparation for the elections

The election period commenced on 12th August and is due to end on13th September 2019.

It was noted that Helen Dykes and Elizabeth Logue have intimated that they do not intend to seek re-election. In relation to the former, it was agreed to discuss the terms of her letter of resignation during a closed session, prior to the conclusion of the meeting.

The Secretary confirmed that he has written to Elizabeth Logue to thank her for her contribution to the work of the Community Council

Graham Paterson reported that he has spoken again with Des Barr of Sinclair Barr whose paper boys and girls had kindly distributed the leaflets on behalf of the Community Council. However, he has again declined any payment.

The Secretary went on to report that as of this evening, only eight nominations have so far been submitted to Renfrewshire Council. Those include one prospective new member. It was emphasised that unless two further nominations are lodged by 13th September at the latest then there is a danger that the Community Council might possibly not be reconvened.

Two members of the members present confirmed that their nomination papers were likely to be lodged the following day

The projects identified in the last SHIP as a priority will progress as carry forward projects within the new plan as detailed within the document.

The Council is inviting comments and feedback on the draft Strategic Housing Investment Plan by 21 September 2019. This will allow them to take account of feedback before submitting it to the Scottish Government in October 2019.

Dismay was expressed that less than three weeks had been afforded to consider and discuss the terms of the Draft Plan.

Notwithstanding, one particular aspect of the plan was highlighted relating to the vacant plot at Auchentorlie Quadrant/Seedhill Road.

The area had previously been designated in the Strategic Housing Investment Plan for affordable housing, However, that is no longer the case.

Members were reminded that previous plans by Williamsburgh Housing Association to develop the site had to be abandoned due to the insufficiency of the sewer.

Following discussion, it was agreed to write to Renfrewshire Council, to ask if they might now be inclined to develop the vacant land, in conjunction with Network Rail Scotland, to form a larger car-park, thereby improving the Park and Ride facilities at Hawkhead Station. This would help alleviate on-street parking issues in and around Seedhill Road. It was suggested that could perhaps also include formation of another entrance/ exit to the station at the west end of the platform.
