1. Chair's Welcome & Opening Comments	
The Chair welcomed those present and thanked everyone for attending the first meeting of the reconstituted Community Council following the recent election, which had fortunately attracted several new members.	
By way of welcome, all members were invited to briefly say a few words to introduce themselves.	
Following that, the Chair thanked everyone for their introductions and, in the absence of any Police or Warden representatives, moved on to the next item on the agenda.	
2. Minutes of Meeting held on 6th September 2023	
The minutes of the previous meeting were proposed as an accurate record by Jean Ramsay, and this was seconded by Gaynor Corry, both returning members who were present at the meeting in question, so those were formally approved without dissent.	Approved
3. Business arising from Minutes of Meeting held on 6th September 2023	
Community Council Election	
Members will be aware that the recent election attracted sufficient nominations to allow the Community Council to be reconstitute.	
14 members have been nominated and returned unopposed as there were not more than 30 nominations.	
Several people who had initially enquired about joining did not manage to get their nomination submitted before the closing date. If they show a keen interest in participating, then they could possibly be potential co-optees in the course of time.	Noted
While it seems that a previous member, Catherine Scally, had submitted her nomination, unfortunately that did not reach Renfrewshire Council in

time. Accordingly, Anne McNaughton has suggested that we might look at co-opting Catherine and has sent her the appropriate form for this purpose.

It is therefore agreed that the question of Catherine's co-option be included on the agenda for the November meeting and hopefully this can be approved.

It was mentioned that one of the new members has highlighted that, due to work commitments, it is not possible to attend meetings on Wednesday evenings.

Accordingly, given that there are a number of new members, it was agreed that it would be appropriate to check at this stage which weeknight would best suit everyone. On a show of hands, no preferences were noted for meetings to take place on either a Monday or Tuesday evening. A clear majority of members present opted for meetings to take place on a Wednesday evening. It was therefore agreed to maintain the current arrangement and for meetings to take place on a Wednesday evening.

The Secretary then went on to refer members to guidance issued in advance of the meeting, aimed at inducting new members into their role and as a useful reminder to existing members.

It was explained that during the month, incoming emails of any importance will be circulated to members for information or as advance notice. Members need only respond when feedback is specifically requested, or they feel that there is a point that they need to make sooner rather than later. Otherwise, if necessary, the matter can be discussed at the next scheduled meeting.

Seven days before each meeting, a calling notice is sent out together with a copy of the minutes of the previous meeting.

A few days before each meeting, the "Bundle", which is essentially a digest of all the relevant emails etc. circulated during the month will be emailed to members. It was explained that there is no need to print off and bring along the full bundle, as much of its content is for information. However, if members require a hard copy of any specific items to discuss, they should inform the Secretary know by 5pm on the day of the meeting so that can be printed in readiness.

The meetings are open to the public and as the recent election has raised awareness of the Community Council, it is hoped to see some more residents attending.

While meetings do tend to have a semi-formal atmosphere, to encourage active participation by members and visitors alike, everyone is still encouraged to speak through the Chair to maintain some order and to make the meeting easier to minute.

The Community Council considers and discusses issues that affect the local

area and the wider civic realm. When members are approached by any individual residents and asked to take up or highlight any personal issues, e.g outstanding housing repairs, anti-social neighbours, missed bin collections etc., where they have been unable to get any satisfaction from Renfrewshire Council, they should be referred on to one of the local Councillors who are better placed to take on casework. There are three Councilors representing each ward (Ward 3 – Paisley Northeast & Ralston and Ward 5 – Paisley East and Central) that fall partially within the CC area. Several Councillors regularly attend our meetings.

People expressing concerns over state benefits should be referred to Citizens' Advice or their MP/MSP.

Concerns over, say, Health Service provision or issues that fall within the remit of the Scottish Parliament should be raised with their MSP.

Members were reminded that all communications in the name of the Community Council must be issued by the Secretary or, on occasions, as circumstances dictate, by the Chair or Treasurer.

The Chair took the opportunity to remind members that Community Councils are non-political, so are not concerned with partisan matters,

Any members who are unsure in relation to any points are of course welcome to contact the Secretary or Chair in confidence.

Access to AEDs / Defibrillators in Paisley East & Whitehaugh

As Linda Murning, who had initially highlighted this issue, has now been elected to the Community Council, it was agreed to continue this to a future meeting in the near future to discuss Linda's own findings and thoughts regarding local provision.

Those concerns relate to:-	
Safety of guests/neighbours	
 Congestion effects Fragmentation of communities – it is felt that if this and other similar Licence applications locally are granted, this will lead to a further proliferation in properties being used for short term lets. In the longer run, this will give rise to disruption through the churn of short-term use. Moreover, a transient population makes it difficult to maintain a cohesive community. 	
 Inflationary impact on rents and affordability in the longer-term rental market. 	
 Reduction in number of properties available for longer-term rental Increase in antisocial activity caused by transient occupants, with noise or rubbish not being disposed of appropriately. 	
It is recognised that there is potential for these issues to be more acute in blocks of flats, properties with a shared main door or tenements, such as these instances and indeed in the case of the subjects at 27 Glasgow Road.	
Hope was expressed that the applicants might reconsider their plans and make the properties available for longer term rent.	
The Secretary confirmed that he would draft an appropriate objection along those lines to be used in relation to all the pending applications and circulate that for agreement prior to submission to the Licensing Section

the drainage system could simply not cope with the deluge. In response, it was suggested that residents should be encouraged to take a more proactive approach to reporting blocked drains so that those can be more readily attended to before the situation becomes acute.	Noted
Other issues included concerns over rubbish at Seedhill Community Sports Ground; an abandoned car at East Buchanan Street and noise from the Lagoon's PA system disturbing neighbouring residents.	
Concerns over Pedestrian Safety	
A concern was expressed from the floor regarding the apparent lack of concern for the safety of pedestrians across the area.	
Cllr McNaughtan suggested that measures to help improve pedestrian safety would be the sort of issue to be examined/addressed in a Local Place Plan.	Noted
Junk Mail/ Leaflets	
It was observed that the growing volume of junk mail, including leaflets, takeaway menus etc. being delivered to households is becoming a nuisance. It can also be problematic insofar as those also seem to be spilling out to litter pavements etc.	
It was mentioned that residents can opt-out of delivery of unaddressed mail delivered by Royal Mail although that does not preclude other companies or organisations distributing those.	Noted
Residents can of course display a 'No Junk Mail' notice in a conspicuous position near their letterbox, although this has no particular legal standing so may not prevent leaflets/adverting material being delivered.	
Fly-tipping	
Instances of fly-tipping at Arkleston Road and Clarence Street were highlighted, which Cllr Clark undertook to highlight to the relevant team, which he mentioned does tend to be very responsive to such complaints once received.	Noted
